I am pleased to announce to you that, following the examination of its application, the city of Bistrita has been designated to become a member of the UNESCO Creative Cities Network (UCCN) in the field of Architecture. I would like to take this opportunity to congratulate you on this meaningful achievement.


Indeed, from now on, your city's engagement and expertise, along with its support to the UCCN Secretariat, either financial or in kind, will be essential to our shared and continued success.
